PLEASE TAKE FURTHER NOTICE THAT the Township Board has received a cost estimate for the scope of the improvement in the amount of \$275 per parcel each year for five years, and the cost estimate has been placed on file in the Township's offices. An estimated cost of \$15 per parcel will be added to the first year's assessment for publishing/mailing costs. The scope of the improvement will include road maintenance services as shown on the petitions. PLEASE TAKE FURTHER NOTICE THAT a public hearing on the petitions for the improvement, the scope of the proposed improvement and the special assessment district to be established for the assessment of the cost of the improvement, and to hear any objections thereto, will be held at the Township Hall, 4363 Buno Road, Brighton, MI commencing at 6:30 P.M. on Monday, November 20, 2023.

At such hearing, the Board will consider any written objections to any of the foregoing matters which might be filed with said Board at or prior to the time of said hearing as well as any revisions, corrections, amendments, estimates and cost to said special assessment district. Any person objecting to the proposed improvement, the petitions referenced above or the proposed special assessment district must file his or her objections in writing with the Township Clerk (clerk@brightontwp.com) before the close of the November 20, 2023 public hearing or within such additional time (if any) as the Township Board may grant.
